'Hanson, Tomkin & Finkelstein.

A partnership in Johannesburg between NL HANSON, S TOMKIN and NI FINKELSTEIN, fellow students at the School of Architecture, University of the Witwatersrand: Hanson joined Tomkin and Finkelstein at the end of 1931, the partnership being thus established. The partners carried out works in a progressive European style in Johannesburg, Pretoria, Springs and Brakpan for about twenty-five years.

Finkelstein left the partnership in 1950 and the style of the firm became Hanson & Tomkin until 1970 when it became SN Tomkin, Hanson & Harris in Durban, until 1978. Hanson's purposeful and decisive qualities, allied to Tomkin's abilities to get work enabled Hanson, Tomkin & Finkelstein become one of the most significant pre- and post-war group of architects in South Africa.
