## **DESCRIPTION OF PLACE:**

This single storey building is situated between two highly decorated buildings, giving the impression that the plain pedimented gable came an afterthought. The entrance is placed of centre and the cloth fabric is typical of the Diagonal 'environment'. (cjmb)

"Although not an outstanding building. It does nevertheless re-inforce the prevalence of this type of single-storey pedimented style of building." (NMC statement, 1988)

## CONSTRUCTION MATERIALS:

- Walls : plastered brick.
- Roof : mono-pitch, corrugated iron.
- Windows: aluminium shop front to street.

No documentation in respect of alterations/additions to this building, could be found.

The glazed aluminium shop fronts would originally have been of timber. The display sign detracts somewhat from the appreciation of the building; it does not respect the architectural features and the visual qualities of the building.
