## DESCRIPTION OF PLACE:

Eight storeys; one basement level. The building is connected to the top storey of the parking garage (between President and Market Streets) by a sky-walk. Extent of site: 4959.0 sqm.

The only part of this building that makes sense is the Sauer Street façade. It is nicely proportioned and the podium effect is rounded off with a cornice. The Pritchard Street façade seems somewhat out of context and the haphazardous placing of smaller structures on the roof is reminiscent of a 'beach front scene'. (cjmb)

## **CONSTRUCTION MATERIALS:**

- Walls : reinforced concrete construction; black, cream and white polished granite panels; bronze coloured panels.
- Roof : flat, concrete.
- Windows: bronze coloured aluminium frames.
- Balustrade: mild steel with cast iron on hand rail (corner of Pritchard and Sauer Streets on small podium).

## **PRE-HISTORY OF SITE:**

By 1889 there stood an undecorated single storey brick building on the President/Sauer Streets corner of this site. By 1910 the owner G. and J. Nathanson had the roof replaced with new corrugated iron. The architect for this alteration was John Adams. The architects Aburrow & Treeby designed a arched ornament above the entrance for the National Bank of South Africa in 1920. By 1890, facing President Street, the first Argus building stood on a portion of this stand. According to plans pertaining to alterations to nearby properties, this building was a five storey structure by December 1912. By 1940 a second Argus building occupied two stands, viz. the site of the former building and an area (facing Pritchard Street) directly behind this stand.

#### **GENERAL NOTES:**

Nurcombe, Summerley, Ringrose & Todd "was a technically innovative firm, but in the early post-war years the great days of Nurcombe & Summerley at Chrysler House were a thing of the past....In the 1960s and 1970s...they experienced a new lease of life, experimenting with tower-block-on-plaza forms." 
