An interesting building bespoke for Williams Hunt South Africa Limited. The ground floor of the building is double volume. This building was constructed with three basement levels designed as parking space – this was a rarity in Johannesburg at the time of its construction.

An appropriate hand painted wall frieze of a sport model car to indicate the Marshall Street parking entrance.

Nurcombe, Summerley, Ringrose, & Todd Charted Architects and Town Planners.

"NURCOMBE, Donald Lansdowne (1 Aug 1900 - 1968) was probably born in South Africa. He was articled to JM SOLOMON & AJ MARSHALL from 1920 until 1922 in both Cape Town and Johannesburg. He also attended a part-time course, organised by the Association of Transvaal Architects, to qualify for registration as an architect. He later studied at the School of Architecture, University of the Witwatersrand and became the first chairman of the Architectural Students' Society in 1926. He was chief assistant to HW SPICER in Johannesburg for a short time around 1927 before he began his own practice in Johannesburg (date?); in 1936 he entered into partnership with HG SUMMERLEY (cf NURCOMBE & SUMMERLEY). The practice was successful, designing many commercial buildings in Johannesburg. Nurcombe seems to have moved to Natal by 1948 where his address at this date was Misty Hill Farm, Hilton Rd, Natal. In his RIBA Fellowship papers he lists as his work Chrysler House (1937), Manhattan Court (1937) and Shinwell Bros building (n.d.) in Johannesburg and the Hume Pipe Co offices in Germiston (1947). "NURCOMBE & SUMMERLEY, a partnership in Johannesburg between DL Nurcombe and HG Summerley from February 1936; the practice flourished and in 1936 won the prestigious competition for the design of the Master Builders' Association Headquarters in Johannesburg. Their best-known building however was Chrysler House, Johannesburg (1936-9). The firm later (n.d.) became Nurcombe, Summerley & Lange..."

The owners should be requested not to paint these. (CJMB)
